The 2023 Assembly resolves on a new EIFI

Prima dell'avvio dei lavori, Anders Karlsson ha invitato i partecipanti ad osservare qualche minuto di silenzio in onore dei compianti Robert H. Lench, Presidente dal 1984 al 1986 e dal 1990 al 2006 e Sergio Pirovano, Membro del Board in rappresentanza di UPIVEB dal 2009 al 2021.

Nella prima sessione assembleare è stato approvato il nuovo Statuto, la nuova Struttura ed è stato eletto il nuovo Board della EIFI. La presidenza dell'Associazione in carico ad Anders Karlsson dal 2009 è passata a Paolo Pozzi mentre sono stati riconfermati Vicepresidenti Enio Fontana e Christian F. Kocherscheidt. Riconfermati anche Jean-Paul Amaro, Alexander Agirre, Geraldine Bolton e Giorgio Donati come Membri del Board in rappresentanza rispettivamente delle Associazioni francese ARTEMA, spagnola ASEFI, inglese CBM e italiana UPIVEB. Wolfgang Scheiding di Ejot eletto Board Member in rappresentanza di Deutscher Schraubenverband e Patrick Lexer di Bulten eletto Board Member in rappresentanza degli altri Paesi Europei. I quattro Gruppi di prodotto esistenti Aerospace, Automotive, Stainless Steel e General Fasteners sono stati ottimizzati in tre Gruppi di Mercato: il Market Group Aerospace, la cui presidenza è stata affidata ad ARTEMA, il Market Group Automotive, la cui presidenza è passata da Paolo Pozzi a Wolfgang Scheiding e il Market Group General Industry & Distribution, la cui presidenza

The 2023 General Assembly of EIFI (European Industrial Fasteners Institute) was held on 12 May 2023 in Meissen, Germany. It was attended by about twenty member companies from France, Germany, Italy, and Spain, along with Guests from various fastener Associations around the world.

Before the proceedings began, Anders Karlsson invited everyone to stand for a moment of silence in honour of the late Robert H. Lench, who served as President from 1984 to 1986 and again from 1990 to 2006, as well as Sergio Pirovano, a UPIVEB Board Member from 2009 to 2021.

In the first meeting session, the new Articles of Associations and the new Structure were approved, and a new EIFI Board was elected. Paolo Pozzi took over as

President of the Association, succeeding Anders Karlsson, who had held the position since 2009. Additionally, Enio Fontana and Christian F. Kocherscheidt were reconfirmed as Vice Presidents. Jean-Paul Amaro, Alexander Agirre, Geraldine Bolton and Giorgio Donati were also reconfirmed as Board Members, representing the French ARTEMA, Spanish ASEFI, English CBM and Italian UPIVEB Associations, respectively.

Wolfgang Scheiding of Ejot was elected as a Board Member representing Deutscher Schraubenverband, while Patrick Lexer of Bulten was elected as a Board Member representing other European countries.

The four existing product groups, namely Aerospace, Automotive, Stainless Steel and General Fasteners, underwent a consolidation process, resulting in the formation of three Market Groups: the Aerospace Market Group, whose presidency was assigned to ARTEMA, the Automotive Market Group whose presidency passed from Paolo Pozzi to Wol-

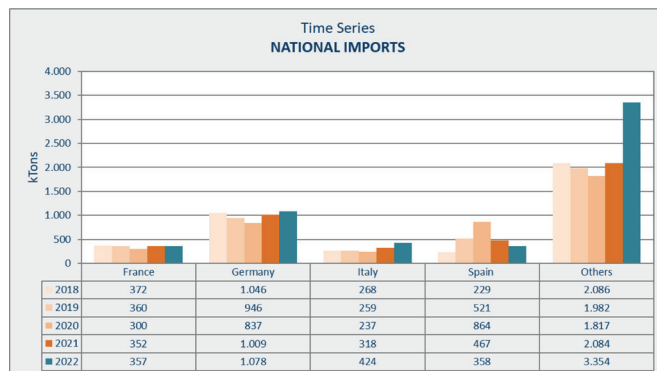

fgang Scheiding and the General Industry & Distribution Market Group, whose presidency was assigned to Ramon Ceravalls of the Spanish ASEFI, who already presided over the General Fasteners Group.

Three Operating Committees have been set up, tasked with developing activities and projects to better cater to the needs of the Association's European manufacturers, and two new member categories have been established: Affiliated Members, supply-chain companies and Associated Members, i.e. leading European companies specialising in Legal, Financial, Consulting, Training and HR matters. Anders Karlsson thanked those present, highlighting that the 2023 Meissen Assembly would be remembered as one of the most successful ever. He expressed his personal satisfaction with the remarkable efforts carried out by the Task Force, a group specifically set up for the "EIFI Future" project consisting of President Karlsson and Presidents of the National Associations. The Task Force held more than twenty meetings from January 2022 to March 2023,

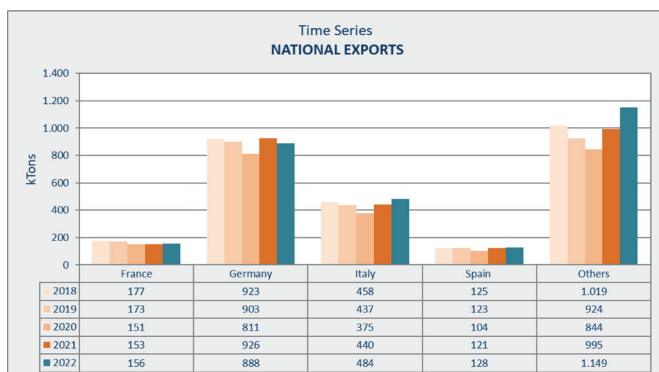

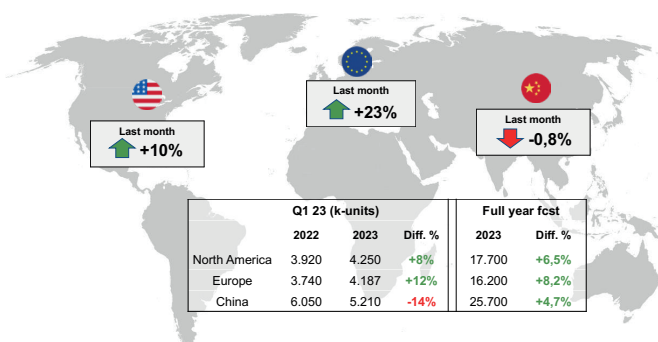

The following is an excerpt from President Pozzi's presentation on the outlook of the automotive industry and the global fasteners market.



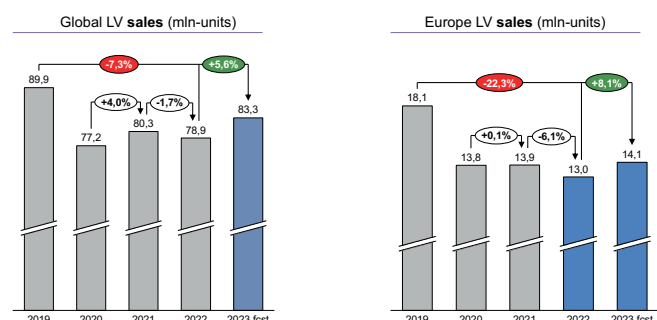
Global Light Vehicle sales Q1 2023

Light Vehicle sales

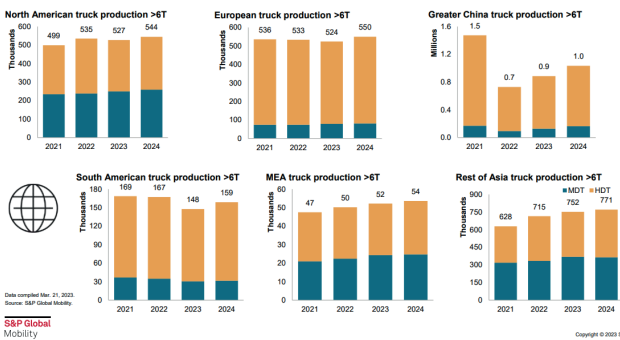


- 2023 forecasts are far from 2019 level (-7,3%) especially in EU (-22,3%)

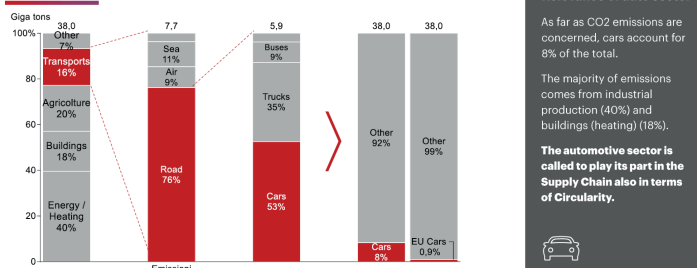
Global Truck Market

As far as CO2 emissions are concerned, cars account for 8% of the total.

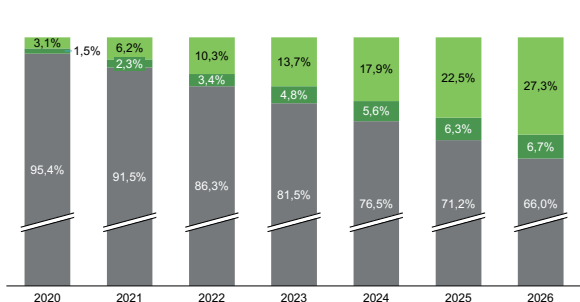
The majority of emissions comes from industrial production (40%) and buildings (heating) (18%).

- EU cars are responsible for a very small share of total emissions

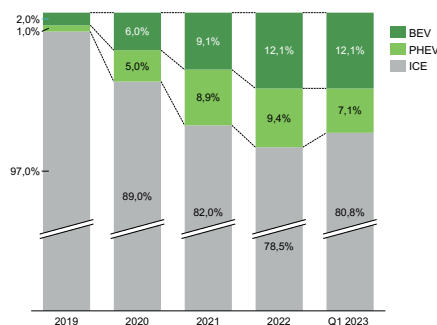
Electrification: global sales trend by engine type

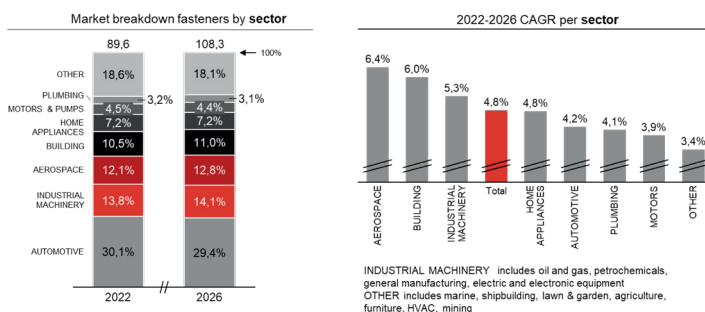
Electrification: EU sales by engine type



- Decoupling from North and South Europe driven by incentives and infrastructures

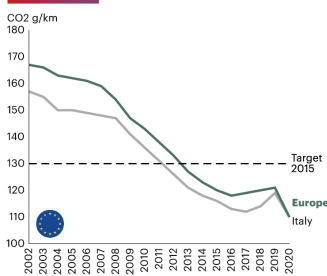

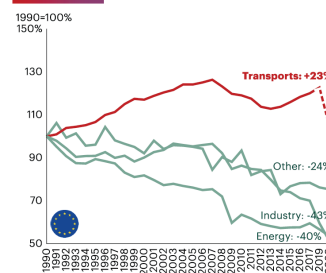


CO2 global context
